GDPR INFORMED CONSENT

Effective: October 18, 2024

This Informed Consent ("Consent") is provided by the Ultra Accelerator Link Consortium, a Delaware corporation ("UALink") pursuant to the European Union's General Data Protection Regulation (the "GDPR").

This Consent is presented to you in your status as an individual ("You" or "Data Subject" or "Your") who is: (i) participating in, making contributions to, and/or supporting any meetings, work groups, activities, collaborative efforts, other events or work products (including without limitation any standards or specifications) sponsored, supported, operated or distributed (in whole or in part) by or on behalf of UALink ("UALink Activities"); and/or (ii) using any programs, technology platforms, or other benefits of any kind offered by or on behalf of UALink ("UALink Benefits"). This includes, without limitation, any individual acting as a representative of, or otherwise on behalf of, a UALink Member as part of that UALink Member's participation in any such UALink Activities or use of any such UALink Benefits.

BY CHECKING THE "I AGREE" OR "CONTINUE" BOX TO THIS CONSENT, YOU (AS AN INDIVIDUAL) HEREBY ACKNOWLEDGE AND AGREE THAT YOU HAVE READ THIS CONSENT, UNDERSTAND ALL OF THE NOTICES PROVIDED IN THIS CONSENT, AND HEREBY AGREE TO ALL OF THE PROVISIONS SET FORTH IN THIS CONSENT AS OF THE DATE OF SUCH CONSENT.

NOTICE AND INFORMED CONSENT

By assenting to this Notice and Informed Consent, You hereby give Your consent and authorization to collect from You the following personal data ("Personal Data"):

- First and last name
- E-mail address
- Phone number
- Mobile number
- Fax number
- Physical address
- Company name
- Title/position
- Credit card or other payment information
- Your calendar or other appointment information
- The Internet Protocol Address or other types of unique identifiers related to You and Your device ("Unique Identifiers") which are automatically generated during Your use of any UALink website ("UALink Website").



UALink may use Your Personal Data for the following purposes:

- To facilitate participation, cooperation, and collaboration in UALink Activities and/or use of UALink Benefits by and amongst UALink, You, all UALink Members, as well as the UALink Member or entity that You represent;
- 2. To provide Your Personal Data to all UALink Members, as well as the UALink Member or entity that You represent, in order to provide them with information or other notifications regarding Your participation in UALink Activities and/or use of UALink Benefits;
- To provide Your Personal Data to any association management company engaged by UALink to assist UALink in gathering, collecting, recording, organizing, processing, storing and/or retaining Your Personal Data in order to allow You to participate in UALink Activities and/or use any UALink Benefits;
- 4. To provide your information to any of UALink's vendors, suppliers, independent contractors, or consultants of UALink in order to assist UALink in developing, providing, operating or maintaining the UALink Website or any other UALink Activities, such as but not limited to third party payment providers, third party third party telecommunications, internet or cloud service providers, or third party event planners ("Third Party Contractors");
- 5. To provide Your Personal Data to UALink collaboration partners such as other Standards Organizations ("Collaboration Partners") to facilitate UALink collaborations with these Collaboration Partners;
- 6. To provide Your Personal Data to UALink's professional advisors such as attorneys or accountants ("Outside Professionals") in order to facilitate the professional advice from those Outside Professionals (collectively, the "Permitted Uses"); and/or
- 7. To use Your Unique Identifiers to allow the UALink Website to automatically transmit and use cookies, web beacons or other similar web technology in order to provide You with better access and use of any UALink Website.

These Permitted Uses may be modified by UALink after giving reasonable notice to You.

UALink will retain the Data Subject's Personal Data for the minimally necessary amount of time to carry out the Permitted Uses.

Providing the Personal Data requested by UALink is a condition of participating in the UALink Activities and utilizing any of the UALink Benefits.

If You are unwilling to provide Your Personal Data, or in the future request that Your Personal Date be erased (pursuant to the notification described below), You may be denied use or access to one or all of UALink Activities or UALink Benefits and/or any of the features or functionalities of the foregoing.

You have the right to withdraw Your approval to all or part of this Consent at any time by giving notice to UALink as outlined below.



You have the right to request at any time that UALink erase (i.e., remove and delete) and/or modify Your Personal Data, or that UALink give you a copy of Your Personal Data, at Your cost (prepaid). This can be done by contacting UALink Administration, who can be reached at the following, admin@ualinkconsortium.org.

In the event you request that UALink erase (i.e., remove and delete) Your Personal Data you hereby acknowledge and agree the following: (a) by doing so UALink has the right to deny You the ability to use or access any UALink Website or to use or participate in any other goods or services provided by UALink; and (b) UALink has the right to retain an archival copy of certain Personal Data to the extent necessary for UALink to satisfy or comply with its tax obligations (including without limitation for any tax audits by any governmental agency) or to otherwise comply with any other laws, regulations, court orders or subpoena.

You have the right to file a complaint with the applicable Supervisory Authority, as defined in the GDPR.

UALink contracts with an association management company ("AMC") to gather, collect, record, organize, process, store and retain Your Personal Data and, thus, shares that Personal Data with its AMC. UALink's contract with its AMC will provide that the AMC will be GDPR compliant.

UALink may share Your Personal Data with other UALink Members. UALink has adopted a privacy policy which requires all UALink Members who receive any Personal Data from other UALink Members to only use that Personal Data in compliance with the privacy policy.

UALink may share Your Personal Data with its Collaboration Partners that UALink engages with as part of UALink's efforts to promote its UALink Activities or UALink Benefits. UALink will contract with these Collaboration Partners to provide that they will only use Your Personal Data in compliance with the GDPR.

UALink may share Your Personal Data with or for use by UALink's Outside Professionals to facilitate the professional advice from those Outside Professionals.

UALink may share Your Personal Data with UALink's Third Party Contractors who assist UALink in the development, hosting, maintenance or overall operation of any UALink Website or any other UALink Activities or assist UALink in providing You with any of the UALink Benefits.

UALink may share Your Personal Data (including without limitation Your Unique Identifiers) with any government agencies or third parties in order to comply with, or otherwise pursuant to, any subpoena, court order or other governmental order, law or regulation.
